4. Discuss and consider action on treasurer's report. Including the payment of invoices, reimbursements, and status of District's deposit of funds;
5. Receive monthly report from Chief Smith with SMHCEMS regarding emergency operation, response times, call volume, training, management activities, and membership;
6. Approve and accept statements and oaths of office for appointed/reappointed commissioners;
7. Discuss and consider action regarding election of officers for Board;
8. Discuss and take action on Texas Comptroller Annual Debt and Financial Information Reporting Requirement;
9. Discuss and consider action on payment plan for reimbursement to SMHCEMS for payment of City of Kyle invoice;
10. Discuss and consider action on possible Umland Fire and EMS Station;
11. Discuss and consider action on annexation of territory not included in the district, including election costs and calendar of election deadlines for November 2019 election;
12. Discussion and possible action on proposed meeting with HCESD No. 5 and Kinder Morgan regarding the natural gas pipeline in HCESD No. 5 and 9 district boundaries;
